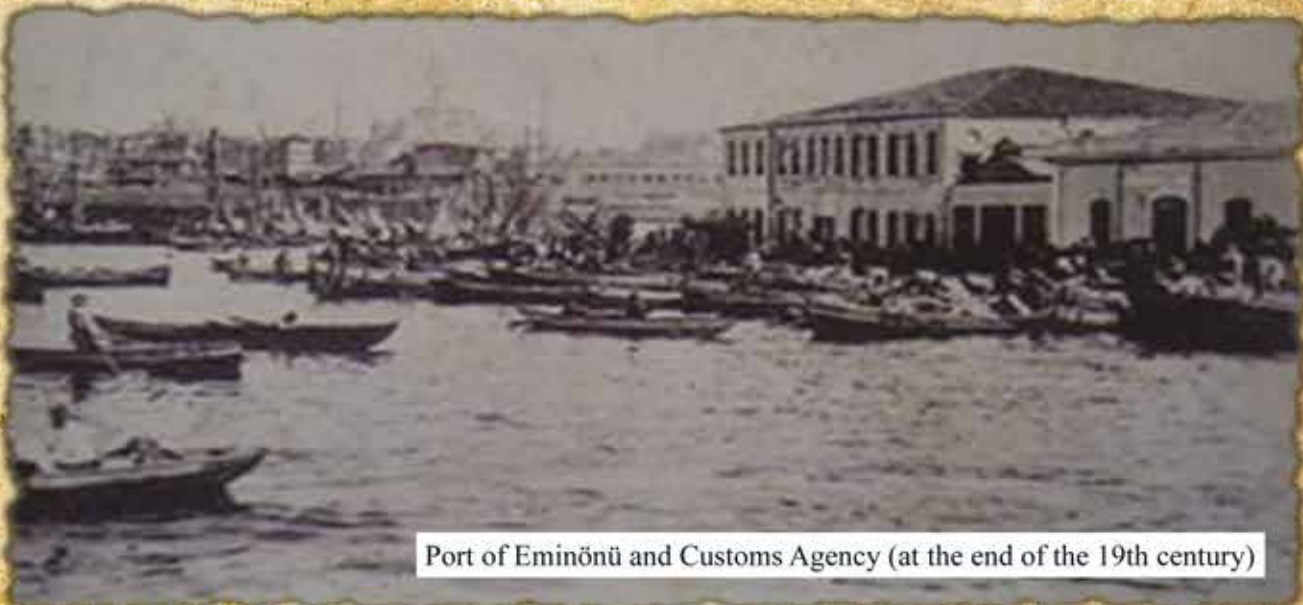

Eminönü Customs Directorate (1915)

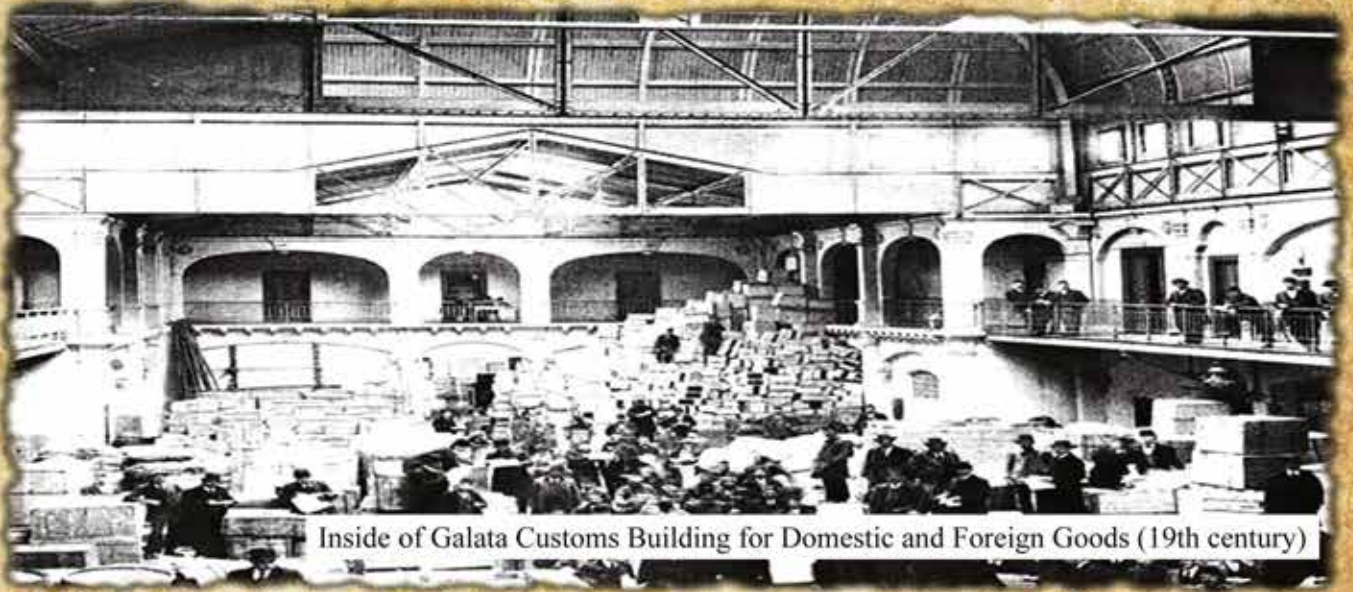


Customs Practices and Taxation History

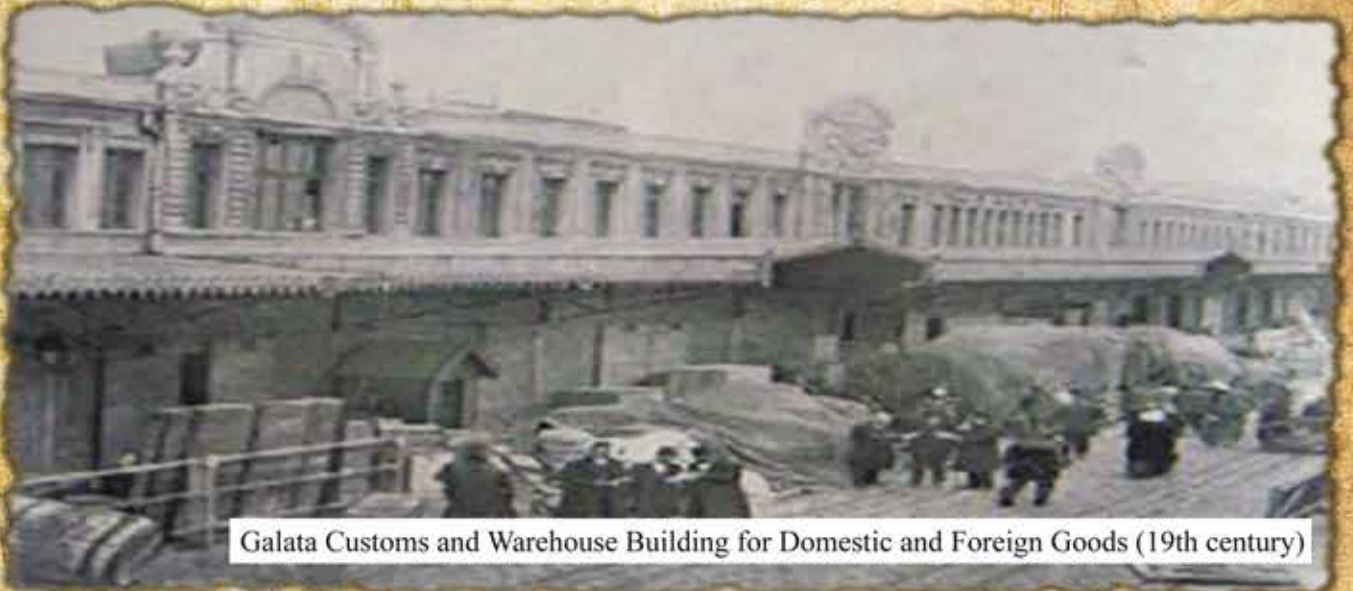
Since the transition periods in the history of humanity, goods, passenger and transportation vehicles, and human entrances and exits have been brought under control; Thus, customs practices were born. The rule of taxation applied for commodities entering and leaving during the ancient Egyptian Civilization period in 3500 BC continued in the Roman Empire as well. Throughout history, trade has always existed, products that were needed because there was no production or were limited, and surplus products were sold. With the emergence of city-states over time, taxation and controls were established within the national borders, within the city or regional borders; Internal customs as well as external customs at initial points of contact with other countries are configured. The taxation system known as "TAMGA" among the Göktürks after Christ was applied by taking the names TAMGA, BAC, MEKS, ÖŞÜR, GÜMRÜK at the establishment of the Seljuk and Ottoman Empires. In our recent history, in the Ottoman Empire, taxes were collected for every commodity when entering and leaving places with customs administration. The tax taken at the entrance of the goods was called *ameniye*, the tax at the exit was called *refsiye*, the tax taken from the goods brought and sold from a foreign country to a city or pier in the Ottoman lands was called *mastariye*, and the tax taken from the goods in transit was called *mururiye*. These taxes were calculated on the value of the goods in that region. When the taxes were paid, the owner was given an "eda certificate" and no tax was charged again when the goods came to another internal customs. In the 1800s, there were over 100 customs points in the Ottoman Empire. Customs tax rates varied according to the province and *sanjak*, and different taxes were applied to Muslims, non-Muslims and warlords. EXEMPTIONS are applied to the goods of state enterprises such as shipyards, armories, arsenals; however, it was also applied from time to time in the importation of grain, agricultural products and breeding animals that the people needed. Exemptions were also granted for the import of tools and machinery that would develop agriculture and domestic industry. Before TANZIMAT, customs were functioning in two ways. In the tax farming method, the customs right was given to tax farmers who made the highest bid for 1 to 3 years, by auction. In the escrow method, the taxes were collected to the account of the treasury through the customs trustees. Customs was named as RÜSUMAT ESCROW in 1861 and now Istanbul, EMINÖNÜ district got its name from the Customs Assurance located in the port here. Between 1909-1923 and 1923-1931, the structure, which was affiliated to the Ministry of Finance as the General Directorate of Rüsumat, became the Ministry on 29.12.1931, taking the name of the Ministry of Customs and Monopolies. With the Decree Law No. 178 dated 13 December 1983, the services provided by the Ministry of Customs and Monopoly and the Ministry of Finance were combined under the Ministry, which was established under the name of the Ministry of Finance and Customs. This structure of the Customs Organization lasted until 1993. With the Decree-Law on the Organization and Duties of the Undersecretariat of Customs, dated 2 July 1993 and numbered 485, the customs wing was separated from the Ministry of Finance and structured as a separate Undersecretariat under the Prime Ministry under the name of the Undersecretariat of Customs. Then, the Ministry of Customs and Trade was established with the decree numbered 640 on 08 06 2011, and finally the Ministry of Commerce was established with the Presidential Decree No. 1 published in the Official Gazette dated 10 July 2018 and numbered 30474.

History of Customs Brokerage

Throughout history, human communities have had to sell the surplus production they have obtained in the region they live in to other regions in need, and have had to procure products and materials that are not produced in their own regions from other regions, and trade has developed in this way. Traders carried out interregional trade and goods movement through caravans in ancient times. Along the way and route through which the caravans passed, the authorities in that region of course set some rules and assigned officials to implement these rules. This structuring formed the first core of the customs administrations. The need for people who have the knowledge and experience to follow the rules and practices and help the goods to be delivered to the final destination without any problems has revealed the customs brokers as a professional group. On the one hand, fair taxation was aimed at the customs at the crossing points and ports, on the other hand, more taxes were tried to be taken. Where there are no tariffs and taxation based on discretionary value, the experts have stood by and helped the parties to act in consensus. During the reign of the Ottoman Empire, the first legal regulation was made with the Instruction dated 25 June 1909, and the profession group, which concluded the customs procedures with follow-up, gained an official identity as "CUSTOMS COMMISSIONERS". During the years of the Republic of Turkey, with the Decree No. 168 dated 16 January 1924, the instruction on Customs Brokers was published; Its qualifications were also determined in the first Customs Law No. 1903 dated 19.06.1927. On the other hand; With the provisions of the Cabotage Law No. 815, 19.04.1926, in short, all kinds of trade and the execution of all maritime tradesmanship professions in Turkey's piers, docks and ports have been made exclusive to Turkish citizens. Thus, citizenship of the Republic of Türkiye has been made necessary for incorporations. Again, with the Customs Law dated 27.10.1999 and numbered 4458, the right to receive the title of CUSTOMS CONSULTANT was given to the members of the profession, and the execution of the profession of customs consultancy was made a prerequisite for citizenship of the Republic of Turkey; In addition to knowledge measurement exams for professional formation, criminal situation and financial qualification conditions have been established. The fees that the Customs Brokers will receive in return for their work and transactions; The Provisional Article 6 of the Customs Law No. 4458 was regulated within the framework of the 10th paragraph added with the Law No. 5911 dated 18/06/2009, and the Minimum Wage Tariff (AÜT) application was introduced for wages. Accordingly, the Customs Brokerage Minimum Wage Tariff, which is determined with the approval of the Ministry of Commerce upon the suggestions and notifications of the Customs Consultancy Associations, is published in the Official Gazette in the form of a Communiqué, announced and implemented every year.

AUTHORIZED ECONOMIC OPERATOR CERTIFICATE (TR: YYS)



Authorized Economic Operator Certificate is an internationally recognized document, which is regulated in the Regulation on the Facilitation of Customs Procedures, recognized by import and export companies and logistics companies. The document is given to companies that have met the institutional requirements, meet the condition of reliability (shareholders and senior managers have not been convicted of specified crimes), have reliable and traceable commercial records (has ISO 9001 and ISO 27001 certificates), have financial competence, and has minimum security in buildings, factories and other facilities, and have met the safety and security requirements and can do their own self-control. Whether these conditions are met is checked by the inspection to be carried out by the Ministry of Commerce Inspector in the field, and a document is issued upon the positive results.

AEO documents are mutually recognized within the framework of the Free Trade Agreement (STA) between us and South Korea. The projects carried out for mutual recognition of AEO documents with the European Union (EU) and other countries with which we have a Free Trade Agreement (STA) are ongoing. By mutually recognizing AEO documents, the company holding the AEO certificate in one country can benefit from the same or similar facilitations in the other country.

YYS document, allows customs inspection to be carried out from the green line, it is not mandatory to submit any document to the customs administration except the electronic declaration and the guarantee amounts are calculated at much lower rates (1% in the inward processing regime in partial guarantee, 10% in other regimes) for importers and exporters. It is a privileged document that does not have to be presented to the customs administration, except for the goods for which laboratory analysis is required, that the goods are customs directly at the company's facilities, transactions are carried out quickly, simply and cost-effectively, and that prepares companies for the supply chain management of tomorrow.

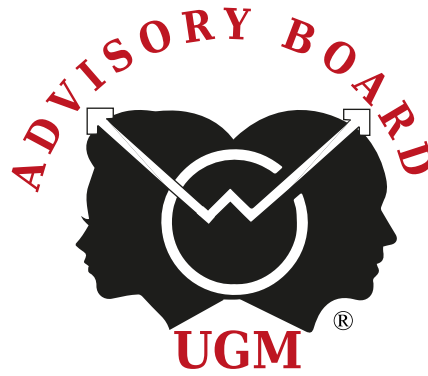

Within the Board, there are chemists located in the Headquarters and UGM Regional Directorates, who have undertaken the task of determining tariffs for textile and chemical products, and our food engineers, whose opinions are sought in determining the tariff of food-type products.

There are also Customs Brokers who have different operational duties among the members of the Board, and the personnel whose main duty is defined as "HS-Code Specialist" only fulfills the task of determining tariffs.

The Ünspeđ Customs Tariff Determination Committee Supreme Board was also established to ensure that the possible differences of opinion of the members of the Ünspeđ Customs Tariff Determination Committee regarding the tariff determination processes can be resolved quickly, even in emergency procedures, and to evaluate the legislation published on tariffs that affect our processes.

Supreme Council; It consists of senior principal members and senior chemists. Committee; has developed its works to meet the requirements of the era and is structured to enable the most comfortable, fastest, and performance measurements and forward-looking information storage, which meets the digitalization norms in terms of demanding tariffs and meeting the demand, through the "Tariff Software System (UGM ERP)" created by our company's software developers.

THE FIRST CHEMISTRY LABORATORY OF THE INDUSTRY AND OUR EXPERT CHEMISTS



One of the main data that should be taken into consideration in cost research before the import process is the tax rates to be applied to the product to be imported. The determination of the taxes to be applied to the goods at the customs clearance stage and other requirements and permits sought during the importation is only possible by determining the customs tariff statistics position (GTIP) of the goods. Considering that, with the decisions taken in the context of product safety in our country recently, almost one out of every three products is subject to product safety inspection, additional customs duty is applied to approximately 5000 products, and surveillance practices are actively used in the foreign trade regime since detection is extremely important, it is clear that the origin of the product and the HS-Code number are required in foreign trade transactions.

The HS-Code, which was previously determined according to the commercial definition of the goods and documents such as invoices, is determined by determining the exact structure of the goods by making detailed analyzes of the products in the face of recent technological developments and increasing product diversity. Whether it is a raw material, semi-finished product, or finished product, for the determination of the HS-Code specific to each item; Firstly it is necessary to correctly determine where the origin of the goods. It should not be forgotten that the better the type and type of an item is determined, the healthier the GTIP will be and the risk of encountering problems in transactions will be minimized. Therefore, nowadays, some physical and chemical analyses may be needed to define many items correctly, which is only possible in chemistry laboratories. In this respect, chemistry laboratories have become inevitable in the sector.

Ünsped Customs Consultancy, with the new chemistry laboratory that it put into service and which is the first in its sector, provides for the goods subject to foreign trade; It aims to provide the opportunity to make an accurate and healthy assessment of the situation of the goods in terms of tariff, value, regime, origin, taxation, preliminary permits, standards, prohibition/restriction measures by making all kinds of analysis. This way, the competitiveness of our foreign trade companies and our country is increased by minimizing waiting costs and errors, and a significant contribution is made to the convenience and effectiveness of public authorities' audits in terms of protecting human and environmental health.

The purpose of the UGM Test and Analysis Laboratory is to analyze the products before the declaration registration and to determine their tariff positions correctly; This way, by ensuring that the HS-Code declaration is made without errors, it provides cost and time advantages to companies by preventing possible financial risks and penal situations.

The SDS includes the hazards of the chemical, the precautions for its use, the emergency scenarios and the legislation that must be followed. This document helps users protect their health and safety, protect the environment, and deal with potential emergencies. In Türkiye, MSDS is prepared as SDS under KKDIK legislation and is prepared in accordance with international standards.

MSDS SCOPE AND AUTHORITY TO PREPARE

The Safety Data Sheet is a mandatory document for hazardous chemicals and products. This document is prepared in Turkish by businesses that produce, import, distribute or use chemicals.

The Safety Data Sheet is prepared in accordance with KKDIK Annex-2 and by a certified chemical assessment expert according to Annex-18.

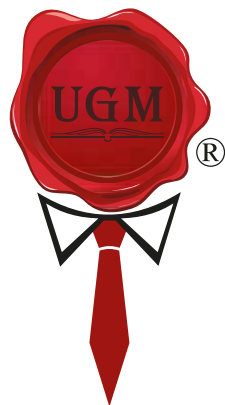

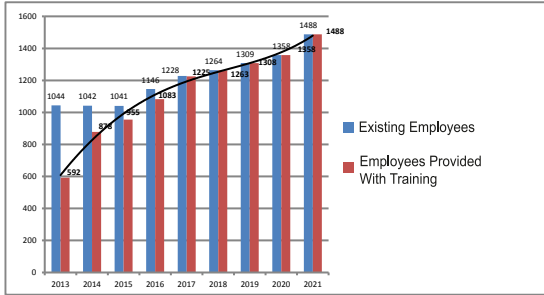

Occupational health and safety training continues to be provided at our headquarters and branches by the regulation.

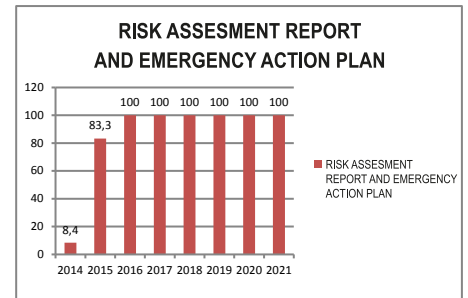


The proportion of personnel receiving Occupational Health and Safety (OHS) training in 2021 is 100%.

Disaster Recovery Center (ODM):

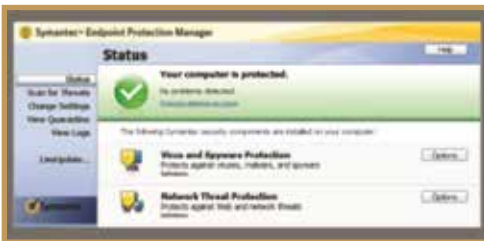

With the security of e-mails, precautions have been taken against e-mail bombardment, spam e-mails, phishing e-mails, e-mails, fake e-mails, and the dangers that may come from them.

Network Security:

Intrusion Detection and Stopping Systems were put into use, with the Firewall controlling the data flow, regulating and limiting the data traffic, and protecting the local network from the internet network. System and network traffic are monitored instantly.

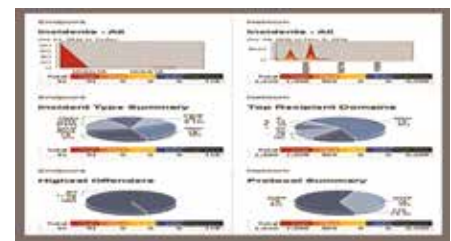
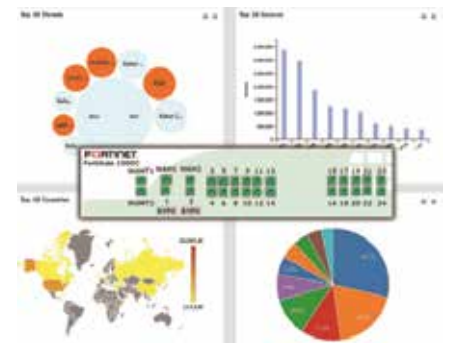
Cooling Systems:

Information Technologies Infrastructure and Systems:

- Türk Telekom protects your data traffic from attacks with anti-DDOS (Distributed Denial-of-Service) Service.



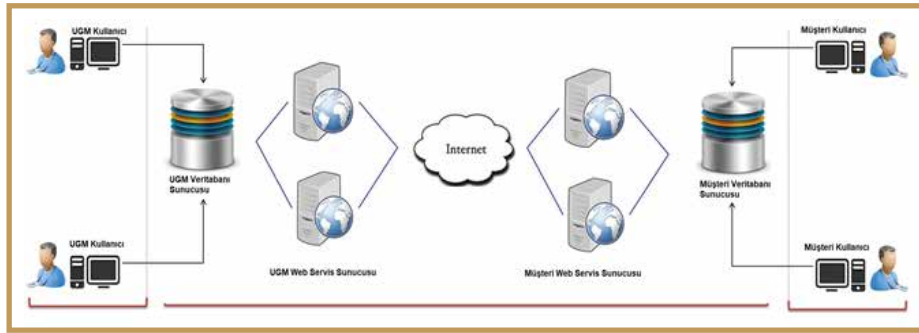
Software Development

- Customer Work Portal-MÇP, with 72 modules in English, German, French, and Japanese languages, provides flexible and dynamic reporting opportunities for all reports of our customers regarding foreign trade processes.
- Apart from this, around 750 special reports have been defined by our customers' business processes. With the measurement program developed by our Software Engineers, all our field and office processes are measured separately based on target times. These measurements; Main, Intermediate, and excuse codes entered for the Import-Export file are separated and calculated. Instant data is received with Mobile Applications on the Field Side. On the office side, with the application used by the Customer Representatives, these data are calculated separately by taking the work tracking code. Target times have been determined with the measurements made by our Industrial Engineers in Customs, Line, and Mode of Transport criteria. These processes are regularly checked every week by the "Business Processes and Efficiency Committee" and process evaluations are made.

In our company's internal processes; Target times have been determined for each import-export transaction. The Customs Tariff and Statistics Position (HS-Code), which is one of the most important elements of foreign trade transactions, is specific to each commodity and is used to define and differentiate products in international trade. The product coding system consisting of 6 numbers and used in more than 170 countries affiliated to the World Customs Organization is called the Harmonized Commodity Description and Coding System, HS-Code and is used in the same way all over the world. No changes are allowed by countries in the HS-Code. The first 8 digits, together with the next 2 digits, are common to countries in the same region (for example, all European Union member states and Turkey). The next 2 digits are used in line with which country's needs and the last two digits determine the full statistical code of the product, thus reaching the 12-digit HS-Code.

The Customs Tariff Statistics Position is used in the following areas

- In the determination of the customs duties of the goods and other taxes and financial burdens collected in foreign trade,
- Keeping national and international trade statistics,
- In determining the rules of origin,
- Determining and collecting customs duty and taxes applied in import and export,
- In trade negotiations (World Trade Organization meetings),
- In foreign trade control, authorization, surveillance, risk-based control in foreign trade, and monitoring of products subject to prohibitions

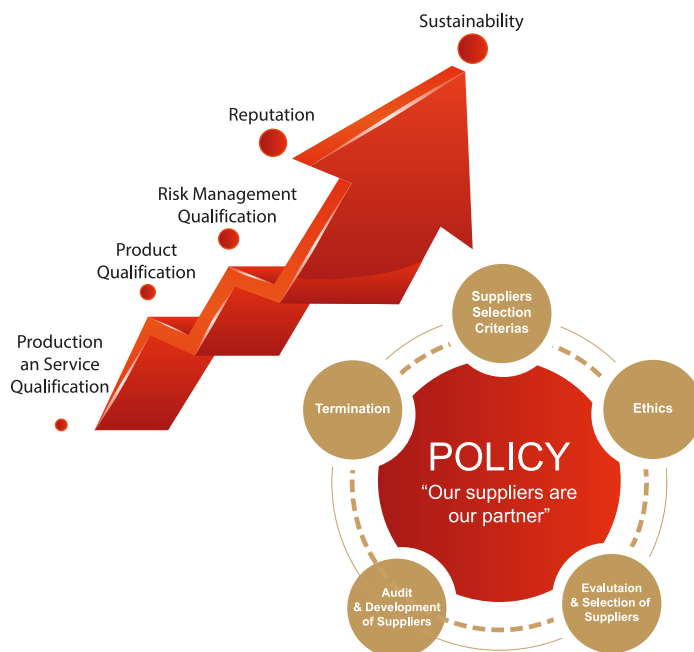

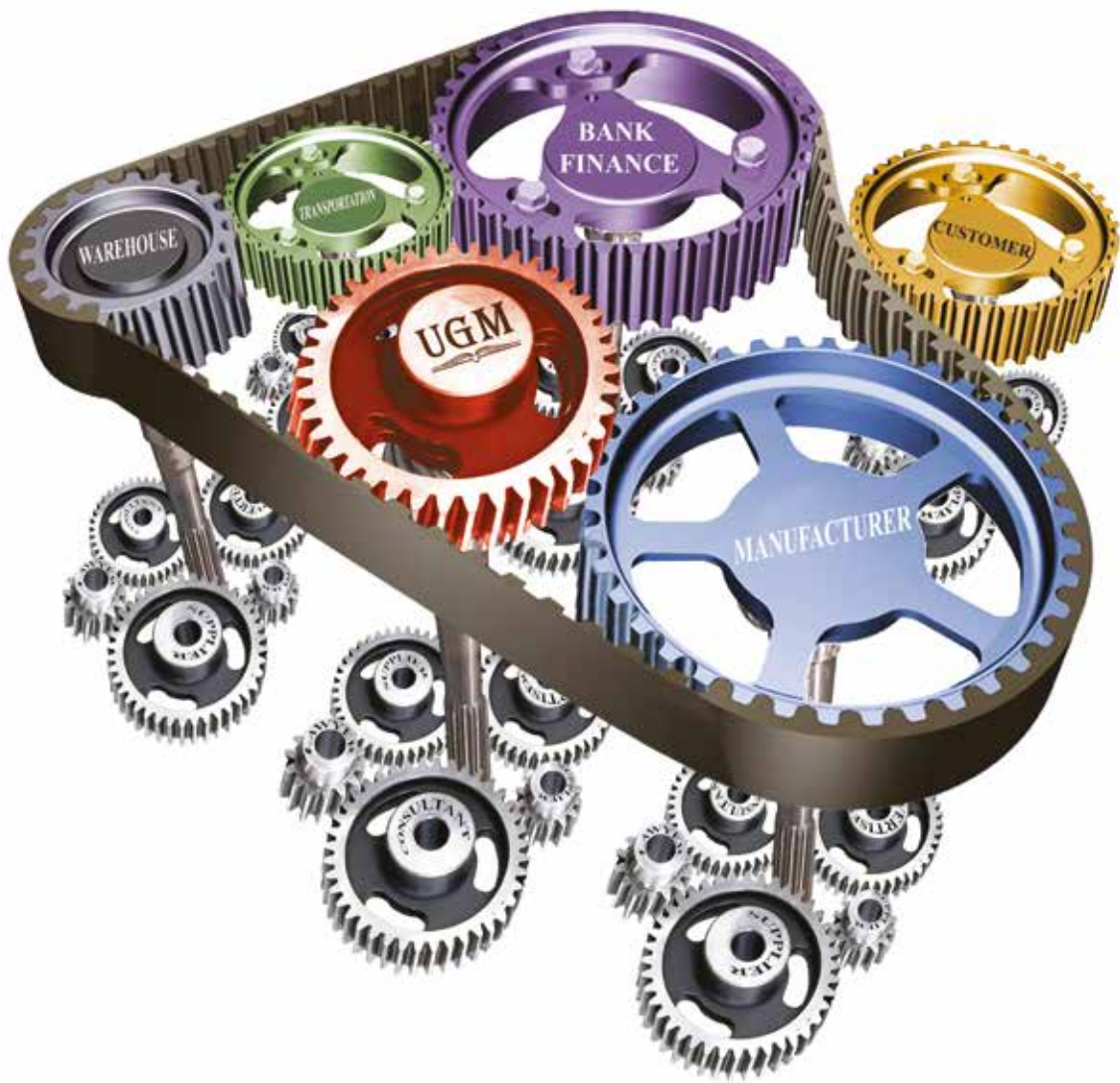

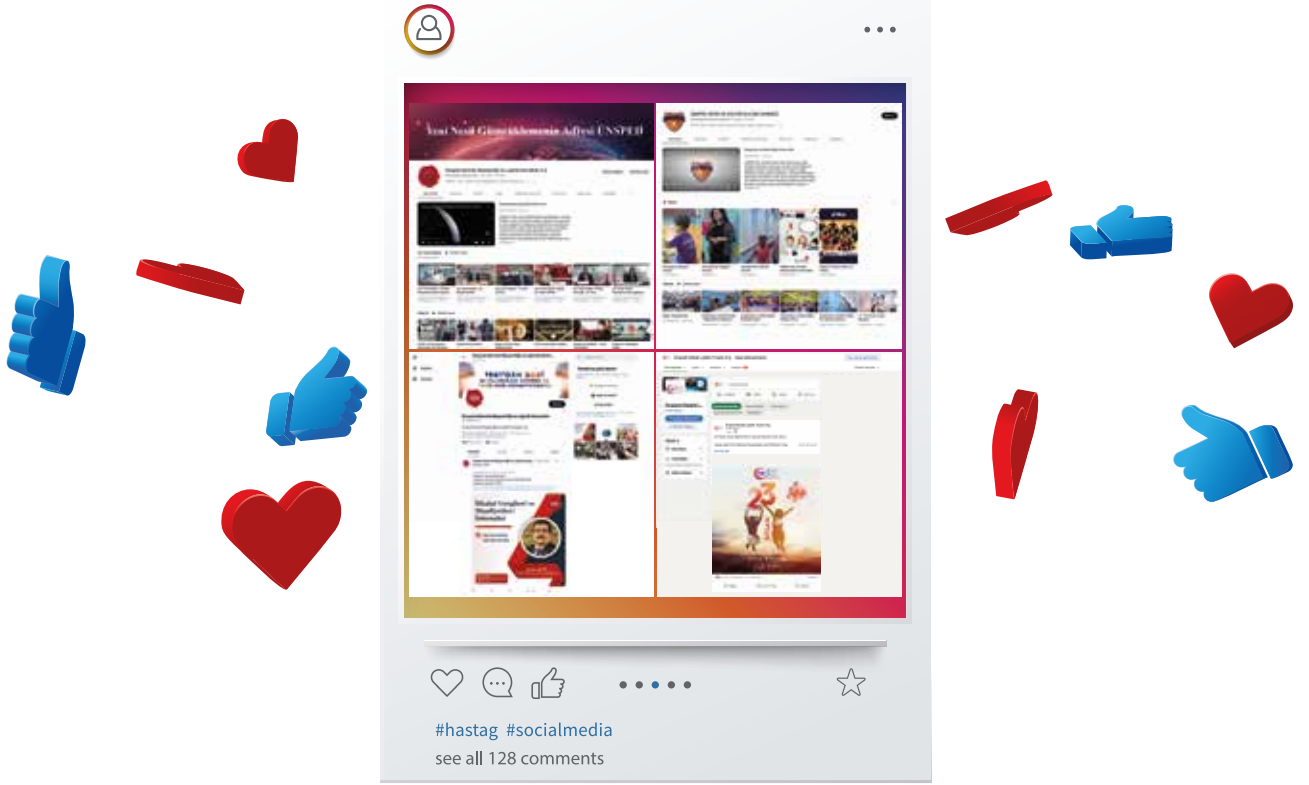
